Rule-2 (TRUST FUND, ACCOUNT, AND AUDITS)

- 1) The trust board should maintain proper accounts of the trust properties either movable or immovable herein after called the trust fund and securities.
- 2) The trustee Suryamani Rout shall be the Chairman and the trustee Sri Budhadev Rout shall be the Secretary of the trust respectively, and shall open a joint Account in any nationalized bank in the name of the chairman and secretary of the trust for daily transactions of the trust income and expenditure as the trust account and maintained in a local national or regional bank as the trustees decided from time to time. Rule-3(AMMENDMENTS)

That, the rules and articles of the trust can be amended and new rules and articles can be included by the trust board further as passed in the resolution made by the trustees in the trust board meeting from time to time by a minimum of 2/3rd majority of opinion in the trust board if more than two members.

Rule-4 (DISQUALIFICATION)

That, the provision for disqualifying are to be confirmed as per the Indian Trust Act-1882 and further the trust board has the powers to disqualify any trustees on the following causes.

- 1) If found guilty in keeping the faith of the trust board.
- 2) And in causes that is/are not acceptable by the trust board.

Rule-5(NEW MEMBER)

- 1) That, the inclusion of the new members as trustee in the trust board shall be regarded only by the willingness and interests of all the existing trustees of the trust board as and when required.
- 2) That, the vacancy caused by resignation, bankrupt or otherwise incapable to cut in terms of any of the trustee be filed up if so desired by all the trustees only the pending the appointment of the new trustees the remaining trustees shall continue to administer the trust.
- 3) In case of death of a trustee the vacancy caused will be filed by the successor or any legal representative or the nominee of the said trustees as per the Indian Trust Act-1882. New member Arabinda Swain, S/o- Bhikari Charan Swain, Dukhabandhu Barik, S/o-Bholanath Barik and new member is accepted as per the resolution. Hence the trust deed is registered and executed out of previous deed. No other alteration or addition is made except change of member.
